IWC EDUCATION BURSARY









The IWC is proud to announce a global initiative to help students further their education in wine.

In collaboration with the Wine & Spirit Education Trust, the IWC will contribute towards course fees for the WSET Level 3 Award in Wines or the WSET Diploma. In line with the global vision of both organisations, and with the objective of stimulating diversity and inclusion in education, this bursary is offered to students who are resident outside the UK.

Level of Support

- 1. The IWC will contribute up to:
 - £500 towards course fees for the WSET Level 3 Award in Wines and Spirits; OR
 - £1000 towards course fees for the WSET Diploma.
- 2. The IWC is committed to furthering the wine knowledge of members of the wine trade. Every year, 'Associate Judges' are invited to taste alongside professionals where they receive first-hand experience of judging at a world class level. Though their marks are not included in the final score, this opportunity further enhances their knowledge of wine styles from around the world. Each year, the IWC Bursary Diploma student with the highest final score in their Diploma will be invited to be an Associate Judge at the IWC in London in April. Travel and accommodation will be paid for by the IWC.

Eligibility Criteria

 The bursary is only available to financially disadvantaged students who are ordinarily resident outside the UK. Some markets are particularly under-represented or present specific challenges to students seeking funding. To address this, applications are particularly encouraged from students resident in Africa or South/Central America.

- The bursary is only available to those wishing to further their existing education in wines and spirits. Therefore:
 - To apply for a bursary towards a Level 3 course, students must already hold the WSET Level 2 Award in Wines and Spirits.
 - To apply for a bursary towards a Diploma course, students must already hold the WSET Level 3 Award in Wines and Spirits.
- The IWC seeks to support those who would not otherwise have the means of accessing educational opportunities with the WSET. Candidates with other means of funding (e.g. employer sponsorship) will not be considered.

Application Procedures & Deadlines

- Candidates are responsible for identifying a suitable course at their local WSET Approved Programme Provider (APP). They do not need to enrol but must identify the course and APP on the IWC Bursary Application Form.
- Applications can be made between June and February. We are unable to process applications during IWC competition time (March – May).

- Both successful and unsuccessful applicants will be notified via email within 28 working days.
- 4. Applicants must submit the following:
 - a. IWC Education Bursary Application Form;
 - b. Brief resume of career to date;
 - c. Documentation of earnings (12 months up to time of application);

- d. Letter of motivation (no more than one A4 page) stating how the Bursary and subsequent completion of the Level 3 Award or Diploma will assist in career development plans. Applicants currently employed in the wine and spirits and related industries (e.g. hospitality) should include information as to whether they are entitled to any financial or other support (e.g. study leave) from their employers.
- 5. Incomplete applications will not be considered

election

- 1. IWC will select candidates based on:
 - · Eligibility (see above)
 - · Demonstrated financial need.
- In the event of there is not sufficient funding for all applicants, IWC will use the letter of motivation to differentiate between candidates.
- IWC's decision is final and no correspondence will be entered into.

Terms and Conditions of Funding

- 1. If granted, the bursary must be used no later than the end of the academic year following the one in which the bursary is granted.
- Bursary students must submit a follow-up report summarising their experience on the course, reporting their results, and outlining their future professional and/or educational plans within 28 working days of receiving their exam results.
- 3. The IWC and/or the WSET may use quotes from Bursary students in their publications. If you do not wish your statements to be used for that purpose, please make that clear at the time of submission.
